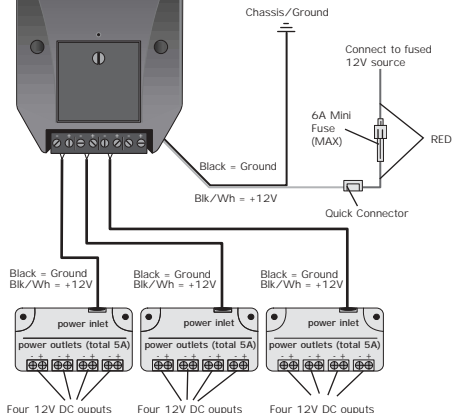
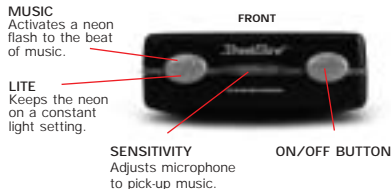

INSTALLATION INSTRUCTIONS:

- 1) Locate and mount the Music Interface in a desired location with 2 small mounting screws provided.
- 2) Connect the 6 amp fuse holder to the BLACK/WHITE striped wire of the module using the Quick Connector provided. Then connect input of the fuse to a 12v source.
- 3) Connect the BLACK wire of the Music Interface to chassis ground of the vehicle.
- 4) Mount Power Distribution Blocks close to the Music Interface with the large screws provided.
- 5) Connect Power Distribution Blocks to module's output.
 - BLACK wire connects to negative (-) output of module
 - BLACK/WHITE Stripe wire connects to positive (+) 12V DC output of module
- 6) Enjoy!
